

INGRES CONTRIBUTION AGREEMENT

Thank you for your interest in contributing to the Ingres Corporation product development community. Ingres is very interested in receiving your contribution to Ingres's products (the "Ingres Product(s)"). In order to participate, however, we need to confirm how the rights in your contributions ("Your Contributions") will be allocated. Following the practices of other open source companies, Ingres requests that you assign to Ingres joint ownership to the copyrights, patents and other intellectual property rights in Your Contributions to Ingres. Ingres requires that you have a Contributor Agreement on file prior to using any of Your Contributions. This Contributor Agreement is to make clear the rights between the parties.

If you have not sent us a signed Contributor Agreement, please review and sign the Contributor Agreement and send it by facsimile to Ingres at 650-249-2026, or send an original by regular mail to Ingres Corporation, 500 Arguello Street, Suite 200, Redwood City, California 94063, Attn: Legal Department. Please read this Contributor Agreement carefully before signing and keep the original for your records.

In consideration for the potential inclusion of Your Contributions in the Ingres Product and for other good and valuable consideration, the receipt and sufficiency of which you acknowledge, you, on behalf of yourself if you are an individual, and on behalf of your company if you are signing this Contributor Agreement as an authorized representative of your company, agree to the following terms and conditions:

1. The term "Your Contributions" means all of your past, present and future contributions of object code, source code and documentation to Ingres, however submitted to Ingres, excluding any submissions that are conspicuously marked or otherwise designated in writing by you to Ingres as "Not a Contribution" at the time of contribution.
2. You assign to Ingres joint ownership to all right, title and interest worldwide in all patents, copyrights, related moral rights, and other intellectual property rights (together, "IP Rights") for the full term of their existence in and to Your Contributions to Ingres and Ingres shall be able to record this assignment. If the moral rights are not assignable, you agree to waive their enforcement against Ingres and its sublicensees, either direct or indirect. You make Your Contributions and your assignments free of charge to Ingres.
3. You represent that you are legally entitled to assign the rights, title and interest as set forth in paragraph 2. If you are an individual and your employer(s) or third parties have rights to intellectual property that you create, you represent that you have received permission to assign Your Contributions to Ingres on

behalf of that employer or third party, or that your employer or that third party has waived such rights in Your Contributions.

4. You represent that, except as expressly disclosed in Your Contribution submission(s), each of Your Contributions is your original creation and does not include, and is not derived in any way from, pre-existing code or any code from third parties, freeware, shareware, electronic bulletin boards or the Internet and that no open source or freeware is included in Your Contributions. You represent that Your Contribution submission(s) include complete details of any license or other restriction (including, but not limited to, related patents, copyrights and trademarks) associated with any part of Your Contribution(s) (including a copy of any applicable license agreement). You agree to notify Ingres of any facts or circumstances of which you become aware that would make your representations in this Agreement inaccurate in any respect.

5. Except as stated herein, you provided Your Contributions AS IS, WITHOUT WARRANTY OF ANY KIND AND DISCLAIM THE WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT.

6. IN NO EVENT SHALL EITHER PARTY BE LIABLE TO ANYONE FOR ANY CONSEQUENTIAL, SPECIAL, INCIDENTAL OR INDIRECT DAMAGES OF ANY KIND ARISING OUT OF THE USE OF YOUR CONTRIBUTIONS, EVEN IF THE USER HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. IN NO EVENT WILL INGRES HAVE ANY LIABILITY FOR ANY CLAIM, WHETHER IN CONTRACT, TORT OR ANY OTHER THEORY OF LIABILITY.

7. This Contributor Agreement shall be governed by the laws of the State of California as such laws are applied to agreements entered into and to be performed entirely within California between California residents and by the laws of the United States. You agree that the United Nations Convention on Contracts for the International Sale of Goods (1980) is hereby excluded in its entirety from application to this Contributor Agreement. In the event of invalidity of any provision of this Contributor Agreement, the parties agree that such invalidity shall not affect the validity of the remaining portions of this Contributor Agreement. This Contributor Agreement is the entire agreement between you and Ingres relating to the subject matter of this Contributor Agreement which supersedes any prior agreement, whether written or oral, and may be amended only by a writing signed by both parties. This Contributor Agreement can be assigned by Ingres without consent or notice. The parties hereto are independent contractors, and there is no relationship of principal to agent, employer to employee, or franchisor to franchisee between the parties.
